Subject: Hon'ble Prime Minister's visit to Shimla on 31.05.2022 - reg.

Sir/Madam,

This is with reference to DO letter no. 18026/02/2022-P&P, dated 16th May 2022 **(copy enclosed)** regarding nation-wide interaction of beneficiaries with the elected representatives including those of PRIs, civil society organizations, families of freedom fighters to not only look at the impact of various schemes launched by the Government of India but also to discuss as to how these could be improved upon so as to lead to a life of dignity to all and to prepare the nation for further socio-economic ascendancy. This programme will be led by Hon'ble Prime Minister from Shimla, Himachal Pradesh on 31st May 2022.

2. State/UT Governments are requested to organize the interactions at the State/UT capitals and district headquarters and assist the KVK centers in organizing the same on 31st May 2022. Necessary arrangements are to be made to connect these interactions virtually to the national event at Shimla, from where Hon'ble Prime Minister will interact with the beneficiaries of the 13 Schemes both physically and virtually.

3. For the District level event, State/UT Governments have to select about 20 beneficiaries each of the 13 schemes mentioned in the para 4 DO letter. Overall, approximately 500 or more participants may take part in a district level function. It is desired that, if possible, a common set of beneficiaries may represent more than one schemes/programmes. *

4. In view of the above mentioned DO letter, you are requested to direct the concerned officials to make necessary logistics arrangements at the programme venue so that the participants can join the national event through virtual mode and watch. Hon'ble Prime Minister will interact with one/ some of the beneficiaries of one or more districts of your State/UT through videoconferencing. Leased lines etc. may be arranged at as many venues as possible so as to facilitate participants' interaction with Hon'ble Prime Minister.

5. It has been decided that Hon'ble Prime Minister will interact with 4 beneficiaries each from 20 districts across the country, the information regarding the same will be communicated separately. Therefore, States/UTs are requested to identify at least 4 beneficiaries who have availed the benefits of SBM- Urban, PM SVANidhi including PMAY(U) from each district of your State/UT who may interact with Hon'ble Prime Minister. In this regard, you are requested following:

- i. Share the detail list of selected beneficiaries to the undersigned for the proposed interaction with the Hon'ble Prime Minister as per details above.
- ii. Showcase short-films on the Missions, testimonials of the beneficiaries during the said event.
- i. Undertake social media and widespread outreach activities regarding the achievements of the schemes/programmes during pre and post event.

6. In view of above, you are requested to issue directions to the concerned officials of your State/UT to ensure maximum participation in the event from across. We look forward to your support in making this event grand success.
