### NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 91 read with sub-section (5) of section 77 of the Jodhpur Development Authority Act, 2009 (Act No. 2 of 2009) the State Government hereby makes the following rules, namely :-

1. **Short title and commencement.**- (1) These rules may called the Jodhpur Development Authority Appellate Tribunal Rules, 2017.

(2) They shall come into force on or from the date of their publication in the Official Gazette.

2. **Definition.**- (1) In these rules, unless the context otherwise requires,-

- (a) "Act" means the Jodhpur Development Authority Act, 2009 ;
- (b) "Authority" means Jodhpur Development Authority constituted under section 3 of the Act ;
- (c) "Form" means form appended to these rules;
- (d) "Section" means section of the Act; and
- (e) "Tribunal" means the Jodhpur Development Authority Appellate Tribunal, constituted under sub-section (1) of section 77 of the Act.

(2) Words and expressions used but not defined in these rules shall have the same meaning respectively assigned to them in the Act

3. **Procedure for filing appeal.**- (1) Every appeal shall be preferred in the form of a memorandum signed by the appellant and his
