NOTIFICATION

In exercise of the powers conferred by section 73 of the Rajasthan Land Pooling Schemes Act, 2016 (Act No. 14 of 2018), the State Government hereby makes the following rules further to amend the Rajasthan Land Pooling Schemes Rules, 2020 namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Land Pooling Schemes (Amendment) Rules, 2026.

(2) They shall come into force at once.

2. Amendment of rule 15.- The existing sub-rule (3) of rule 15 of the Rajasthan Land Pooling Schemes Rules, 2020, hereinafter referred to as the said rules, shall be substituted by the following, namely:-

“(3) The authorised officer of the appropriate authority may, on an application of an owner of any plot included in the sanctioned final scheme, issue an allotment letter in such form and in such manner as may be determined by the State Government, from time to time. After deposition of charges as specified in the said allotment letter, authorised officer of the appropriate Authority shall issue lease deed with site plan to the Allottee/Successor/Assignee in such form and in such manner as may be determined by the State Government, from time to time.”

3. Deletion of Form-I.- The existing Form-I appended to the said rules shall be deleted.
