## Office Order

Sub: - Guidelines for preparation of Zonal Development Plan.

To implement the Master Plan in their right earnest spirit, to give a boost to planned development and in order to detail out the proposals pertaining to Master Plans, the State Government has taken a decision to prepare Zonal Development Plan for all towns of Rajasthan. These Plans will serve and provide opportunities of independent planning by putting focus on those sub objectives which is the uniqueness of that zone.

The Zonal Development Plan shall be prepared by the Senior/Dy. Town Planner of the concerned Zonal/Regional office of Town Planning Department, either through consultant or in-house within a given-time frame in consultation with the concerned Urban Local Body. The Zonal Development Plan shall be prepared under the relevent provision of Rajasthan Urban Improvement Act, 1959 or Rajasthan Municipal Act, 2009 as the case may be.

Since the property level detailed base map and existing land use is required by the Urban Local Bodies for various Municipal Service Such as Building plan Approval, UD Tax, Regulating Unauthorized construction, Land Title, change in Land Use etc., therefore the Zonal property level Base Map & Existing Land Use Map shall be prepared for areas falling under municipal limit of all the Towns.

The Zonal Development Plan will detail out the proposals of the Master Plan and thus will act as a link between the Layout plans and Master Plan. It will contain a Property level Base Map & Existing Land Use, Zonal Level Land Use Plan & Development Proposals as per Zoning/Development Control Regulation, Proposal for Social Infrastructural Facilities such as Educational, Health, Recreational Park & Open Spaces, Play grounds, Community Facility etc. and Physical infrastructural Facilities such as Sewerage, Drainage, Water Supply, Electricity, Solid Waste Disposal etc. Right of way of all the Roads, Road network plan and land reservation for water bodies, forests etc. and other specific provision as per zone requirement if necessary. The Technical Guidelines issued vide order No. F.59 STP/DLB/ Review of M.P.(55)/14/2866 Dated 26.03.2018 shall be adhered to, for providing various Social/Physical Infrastructure facilities.
